Due to the Spring 2020 East Central season being canceled it was decided that East Central will be using the 2018-2019 player counts for voting rights at the 2020-2021 AGM

Proposed billing for Fall 2020 – Adjustments to proposed dates

- Player counts will be pulled from Demosphere on September 12, 2020
- Invoices will be emailed to clubs by September 15 2020
- Invoice due date October 1, 2020 October 15, 2020
- Past Due payments 5% applied after October 1, 2020 October 15, 2020 postmark date
- No Fall 2020 player fees will be refunded/reimbursed after first scheduled game of Fall 2020 season is played

Discussion took place over the proposed billing process for player fees Fall 2020.

- There will not be any refunds of players after the September 12th date as East Central has incurred bills to get the schedule processed and ready for play.
- East Central has a fine in place if any team decides to be removed from an approved scheduled. There is no need to add anything to the proposal on the billing side for teams withdrawing from the fall league.
- Invoice due dates are usually 30 days after invoice. A request to move the payment to October 15, 2020 was made. This would also apply to the 5% past due fee to be applied after October 15. As long as the envelope is postmarked October 15 there will be no past due payments placed on the player fees of the club being invoiced.
- Clubs that have approved teams will be invoiced a player fee. Teams will need to be approved in order to play this fall. Remember that East Central is still invoicing per player. In order to get the classic player billing counts, your players must be on a team that is approved by the district registrar to play fall soccer. Academy pools are considered recreational and can approved by your club registrar

Motion: Sam Bass (Electric City) motioned to approve proposed billing for East Central Fall 2020 League to be sent on September 15, 2020. Payment due date moved to October 15, 2020 to give clubs 30 days to get the payment processed. The fee will be generated by the number of players that have been assigned to approved teams.

Scheduling Proposal - See attached

Discussion:

- Concern about having enough volunteers to coordinate back to play protocol if some teams are away and some teams are home in cluster groups.
 - Suggestion that East Central schedule all of the clubs small sided games home and then give a buffer of time for the referees to move to another field for a second set of games.
- East Central reduced the number of scheduled games to 6 to accommodate flexibility in scheduling
- East Central will **not** reduce the player fees if the number of games in a season is reduced
 - o East Central still has fixed expenses to create schedules.
 - o Some clubs structure their fees with the number of games the player gets. Others clubs say they are charging for player development. Each club is unique in what services they offer.
- Last year we had zero games. A six game schedule is a good way to ease players back into the sport.
- The last two weeks are open to add to the flexibility of scheduling games and to allow clubs/teams to set up scrimmages to round out the season if they so desire.
- The number of games that East Central offers in a season will not have any bearing on teams being placed on state league teams. WYSA really just looks at the record of the team.

It was decided that the membership would vote on the scheduling proposal for classic only. Academy will have a meeting to determine how their season will be played.

Motion: Mark Frierdich (Water Cities) motioned to approve the six week proposed Fall 2020 classic scheduling and game dates.

Due to COVID19 and a shortage of referees in the district, East Central has gotten creative with scheduling for East Central League Fall Games.

The dates listed above are set aside for scheduling weekends. Should games be canceled due to weather a cluster of games could be rescheduled to one to the opened weekends at the end of the season. Also should a team blackout a date for a tournament they may be scheduled in one of the open weekends. The scheduling committee will try their best to put games in areas that make the most sense.

Classic: East Central will be using a cluster scheduling method. Meaning that teams using same size field will be scheduled in clusters of four games to utilize a three-man referee team. Both genders will be scheduled on either Saturday and/or Sunday. There is no longer a specific date for gender game scheduling. East Central will NOT be using the Demosphere scheduling tool for the fall schedule. This will be done to avoid any scheduling charges should the fall schedule need to be canceled. There will be no formal rescheduling of games if a team is unable to make a scheduled clustered play date. Clubs are free to set up scrimmages to make up for and scheduled games they have missed. Communication of any team unable to play a cluster scheduled game will need to be communicated to the opposing team and to the host club holding the clustered play date. Canceling a game will need to be done two weeks before scheduled game so the times can be adjusted for the referee crew and the teams still attending. Canceling a scheduled game should be avoided at all cost and clubs and teams must do their very best to know the team's availability before scheduling starts. Canceling a game because a coach is not available is not an accepted reason to cancel a game. Clubs must communicate with their teams that the fall schedule will not be easy to change and that they consider their request before attempting to cancel any scheduled game.

Reasons for cluster scheduling is to:

- address the shortage of referees utilizing three-man referee group at one location
- minimize the number of fields needed for fall game play

Classic teams will be allowed to select 4 blackout dates.

<u>Academy</u>: Academy scheduling will be done as events. East Central will be using the same scheduling process as in the past. Academy clubs may select two blackout dates to be used club wide.
