Secretary- Approve the minutes for March, 2020

Motion: Mike Jones (Neenah) motioned to approve the March 2020 Minutes. Mike Buman seconded the motion.

Treasurer's Report – See report

Noe Smart reviewed some key items on the current budget.

• Referee Mentoring- Mike Jones is working on getting the money that WYSA collected to support the mentoring program. WYSA initial response was that reimbursement is on hold. Mike will stay in contact with WYSA on this matter and keep us informed on how WYSA is going to handle this program.

Budget notes state: This is a project that was voted on by the full board to allocate \$7000 to a Referee Mentoring Program. It was started in the 2017-2018 fiscal year and will be active for 3 years. Need all club board approval to continue program? expires 2020- 2021

Motion: Kevin Otto (Menasha) motioned to continue to have East Central Support a referee mentoring program in East Central Soccer District

Discussion: Money left in the budget was \$4214.00 and was suggested we keep that money earmarked for mentoring program.

Friendly Amendment to the motion: Kevin Otto amended his motion.

Motion: Kevin Otto (Menasha) motioned to continue to have East Central Mentoring program and to roll over the money in the budget of \$4214 as well as the money WYSA reimburses East Central for the referee mentoring program. Mike Buman seconded the motion.

East Central will have a net loss of \$1670 due to the canceling of the spring season. East Central has enough assets to keep us going until October 2020

Motion: Kevin Otto (Menasha) made a motion to approve the current treasurer report. Chris Billstrom seconded the motion

Approved

East Central will be transitioning the budget to a better way to match up expenses. Request was made to have the budget reflect a profit and loss statement so that we can better understand East Central finances.

Implement a new player/team fee structure – See proposed 2020/2021 Budget 2020 EC Team Fee Spreadsheet.

A discussion about how East Central bills the membership for services of their club

- Recreational players that play in house and do not get any direct services from East Central should not be billed a player fee
- State League Teams are paying the same rate as classic players that play in East Central but are not scheduled in our district. These same teams also pay to be scheduled in state league.
- East Central's primary function is to schedule leagues for our district. Should East Central start charging a team fee to place cost on the teams that receive our services?

- East Central has to figure out a better way to receive money for services and manage its finances. East Central can no longer wait until February to collect money for players.
- The flat team fee was based on maximum number of player's x current player fees
- The finance committee looked at expenses and determined the revenue needed to offset expenses.

Discussion:

- Clubs were concerned about voting rights as East Central currently has in our by-laws that we are following WYSA in using player numbers to determine the number of votes each club has. Committee was asked to look at how to make this equitable. Votes should be proportional to the number of players that are affected by the fees.
- Team fees are based on maximum number of players. Some clubs are not able to fill a team to maximum number so it would be harder for them to pay the team fee.
- Team fees would be collected by using a credit card when a club submits the teams for scheduling in East Central League. Collections of team fees at time of registration might be difficult for some clubs as they may not have a credit card to run at that time. Also it would be cumbersome to run a credit card for each individual team. Suggestion that clubs pay by check once they determine the teams they want East Central to schedule. (Not running this change through Demosphere and adding a credit card fee)
- Teams will only pay for the season that they play.
- Player fees will still be collected but at a lower rate for processing player pass cards

Jay asked if anyone would make a motion to switch our fee collection to team based fees?

Membership did not feel comfortable making a motion as they would like to have time to review the information that was presented tonight. Also many members were on the phone and unable to look at the documents that Jay had shared with the membership.

Motion: Kevin Otto (Menasha) motioned to defer a vote on team based fees until Sunday, May 31, 2020. More information is needed to defined how this process would occur. Jeff Jones (Synergy) seconded the motion

How does East Central obtain player counts

• Entering into WYSA district section of Demosphere program you can select each club and view the list of team names and the total player count with each team. The teams and player count can be exported into an excel spreadsheet. The export does not tell us when the player was added to a team. There is no easy way to tell when a player has been placed on that team. The report reflects the total number of players on the date of the export.

Seeking approval to apply for Corp and Non-profit status

The accounting firm that East Central works with strongly recommended that we update our business status to a 501(c)(3). The estimate that Noe received from them was under \$2000.00. Breakdown of cost is presented below.

Motion: Kevin Otto (Menasha) made a motion to pursue the 501(c)(3) status with East Central's accounting firm at a price not to exceed \$2000. Janice Breitbach (Fox Cities United) seconded the motion

Membership wanted to know if East Central looked into the Paycheck Protection Program. That program was looked at, but the question of our business status was one of the first questions asked. We need to solve this problem first before we can proceed.

Discussion about what to do about the12 month CD at Associated Bank was deferred until the next meeting.
