TOPS - Wayne Stoflet

- Kimberly TOPS: (Wayne Stoflet) Currently, we are not doing anything involving TOPS players. Wayne Stoflet has been following the States Virtual TOPS looking for new ideas. Doubtful that we will do any virtual TOPS anytime soon. Our next opportunity looks like outdoor possibly mid-May until the end of June.
- Synergy TOPS: (Jeff Jones) Not currently active. Hope to have spring session (Apr/May) contingent on risk environment.
- Howard Fire TOPS: (Armando Martinez) completed two of our sessions, and will not have a session next week because the gym is occupied with local elections. We will finalize the winter session with our February 23 and March 2nd meetings. They have 20 players (6 of them are returning from previous sessions with us), ages 3 to 17, so there is a pretty large gap. We are lucky that we have players from our 13 and 16U girl's teams helping as buddies, along with several adult players and coaches. We have limited the capacity inside the gym to 45 people total, everyone (except players) wearing masks at all times. Parents are able to come inside to take pictures or video, but do not stay long inside the gym, rather on the lobby area.

They will be presenting this Saturday's session on Facebook... actually getting ready to submit a brief introduction of the club and the session. Heidi will be coaching and Brooklyn will be setting up the session with the buddies. We reserved a gym and have 5 players and 7 buddies helping.

Howard Fire will have a session outdoors, hopefully mid-June thru July, and we are hoping to have a trip to Chicago in August (we have attended a Chicago Fire trip the last 4 years, obviously weren't able to last year).

2021 AGM

The virtual AGM will be Saturday, March 13. All clubs should have at least 1 representative attend. Packets and information will start to come out this week (week of 2/7).

Important: By-Law change vote. Back in January all clubs were asked to vote on a proposed amendment to the by-laws. East central has done a good job, but there are not enough votes yet statewide. If you haven't voted, do so immediately. <u>https://forms.gle/u7v8As21tWdrjZFg8</u>

The amendment is asking to change Article VIII, Section 1, subsection C - "For the purposes of calculating the number of votes for the 2021 AGM, the number of players is defined as the number of players registered by the Affiliate Member with WYSA during the 2018/2019 seasonal year"

If this doesn't pass and you had no players officially registered during the 2019/2020 seasonal year due to COVID, your club will not be entitled to a vote at the AGM.

2021 Tryout policy

The state shared the approved tryout policy with clubs on January 28. All clubs were able to provide feedback during the crafting of this year's policy. The policies are accessible through the following links:

COVID Protocol

Regardless of any changes to the state wide mask mandates, WYSA policy will continue to require masks for all indoor training activities (WYSA Indoor Play Checklist & Requirements).

For Spring seasons, the policies on COVID used in the fall will remain in effect (<u>WYSA Return to Play</u> <u>Checklist & Requirements</u>). For spring only teams and families, this requires some training on game day seating.
