After reviewing the bylaws and consulting with the WYSA Executive Director, clubs who carry more than one vote will continue to have the right to send one delegate per vote to the East Central AGM. However, in a change of past East Central practice, one person may have a proxy over all the clubs' votes. Proxy voting is consistent with the practices of both Wisconsin Youth Soccer Association and US Youth Soccer Meetings and AGMs.

An example: Club XYZ had 1200 players in the previous year and had 3 votes at East Central Meetings

Before: Club XYZ would need to bring 3 club representatives to a meeting and could cast one vote person.

Today and moving forward: Club XYZ would have the right to bring 3 represents, but only one person would need to be present, and that person may hold proxy over the 3 votes.

2022-2023 Budget/Fees

Some well thought out questions on Team Fees

- 1. What problems is the district trying to solve by moving to a new Team Fee budgeting/revenue stream method?
  - 1. Inequity of services
  - 2. Difficulty and precision of player counts vs team counts
- 2. Is district revenue more perilous with team fees vs player fees

Fees for Non-East Central teams shall be the East Central Team Fee x 1.5 This new fee will amend applicable passages in the East Central Rules and Regulations

Motion: Scott Frisch (WI United) motioned to approve the 2022-2023 East Central Budget and Fees. Mike Jones (Neenah) seconded the motion.

#### **Proposal Goal and Rationale**

The goal is to produce/finish a schedule prior to the start of the season that can be played with minimal changes once the season begins. To achieve this, the district must move beyond some of the bad scheduling habits that we have developed. Clubs, coaches, and teams need to think more proactively when crafting the schedule before the season and resist the urge to be reactive. The plan laid out provides more opportunities for scheduling conflicts to be resolved during multiple scheduling phases and also implements a system which makes in-season rescheduling more difficult and more costly to clubs. Along with a reduction in rescheduling, the new process also hopes to lay out a timeline and consistency that will make the scheduling process easier in seasons to come.

# **Scheduling Timeline/Phases**



Note: East Central will use Mondays and Thursdays at NOON for deadlines, with Thursdays being the start and end dates for all phases

#### **Phase Descriptions**

#### Phase 1 - Team Application, February 3rd-24th

A three-week period in which clubs submit applications for each Classic Team Playing in East Central Leagues. Each team will be allowed to include 2 blackout dates with their application. Teams should review both their Primary and Secondary days of play in May and June and use blackouts for dates they cannot play.

#### Phase 2 - Division Placement, February 24th - March 3rd

A one-week process where the East Central Placement Committee places teams into divisions. The week will be broken down as follows:

- Thursday Sunday: Placement Committee Meets and places teams into initial divisions
- Noon Monday Division Assignments released to clubs, a 48-hour appeals window to question/challenge placements
- Noon Wednesday Appeals Close
- Noon Thursday Final Division Placements released with release of initial schedule

# Phase 3 - Time and Field Assignments, March 3rd - March 10th

At Noon the initial schedule will be released to Club Schedulers, Only HOME games will be visible and only game dates will be assigned. Club Schedules have one week to assign TIMES and FIELDS to all games. The thought process of doing this is four-fold:

- 1. We force each Club Scheduler to engage with the schedule early in the process.
- 2. Clubs can set times to utilize block scheduling to better accommodate ref crews.
- 3. Games can be given proper starting times to accommodate travel (travel time for away team over 30 minutes should be given a 6pm or later start time)
- 4. Field use can be spread over all fields to even turf wear.

# Phase 4 - Initial Date Changes, March 10th - March 24th

At Noon, clubs will now be able to see the full schedule, home and away for all teams, with date, time and field info. The following two-week period is for schedulers to move HOME game dates if there are still problem dates that blackouts did not cover. The guidelines to move change a date are:

- 1. You may only change your HOME games
- 2. Any date change must have the approval of the away team Club Scheduler
- 3. You may not move a game onto a date either team has blacked out
- 4. Games should be moved to open Primary and Secondary days of play for that age division. Only in cases where there are no available Primary and Secondary days of play or in cases where long distinct travel is required may games be played on other days.

Motion: Dusty Rhodes (WI United) motioned to approve New Scheduling/Rescheduling Process with applicable fees and revise the East Central and Regulations to reflect the changes. Mike Jones (Neenah) seconded the motion.

## Friendly Amendments

- Remove the \$25.00 rescheduling fee if a reschedule is denied form the East Central rescheduling committee. Made by Scott Frisch (Wi United) and seconded by Mike Jones (Neenah)
- The team can be added to the scheduling process with no plentily fee till the end of phase 4. Made by Renee Sullivan (Fox Cities United) and seconded by and Scott Frisch (Wi United)

# - No player passes need to be sent in for Red Cards - teams will monitor their red cards & player sits at least the next East Central League Game. Referees will fill out the red card report form in Game Officials within 12 hours after completion of the game.

- Unlimited club pass players at the Classic level games as long as the players are age appropriate.
- Every game should begin with a coin toss by the Referee with visiting team calling it. Team winning the coin toss can choose to take the kickoff or which goal they will attack.

Discussion about High School teams.

The question was raised why we schedule a Club High School Girls Season 15U-19U in Spring.

- Club High School Boys (15U-19U) only play club soccer in the spring season. Boys do not play club soccer in fall because they are playing on their local school team
- Why are the High School girls having two seasons? Fall and Spring?
  - o Spring should be the time for the girls to recover from their local High School season.
  - Club spring games tend to have more reschedules and the number of teams playing are going down each year. Creating competitive schedules for the girls in the spring is becoming harder due to lack of teams
  - o Girl's teams wishing to play Spring/Summer games should sign up for tournaments.

East Central formerly only played club soccer in the Spring. When East Central created the fall season the old practice of having the girls play in the spring continued. Thus, the girls could schedule both a club fall and spring season. Suggestion to review the girls 15U-19U scheduling season next soccer season.
